That I have been allotted a MBBS Seat in Apollo Institute of Medical Sciences & Research, Chittoor by Dr.NTR University of Health Sciences, Vijayawada in Counseling conducted on \_\_\_\_\_ Under the Competent Authority Quota/Management Quota for the academic year 2025-26 for the duration of full course.

That I am aware of the fact that AP Private Medical and Dental Colleges Managements Association, Vijayawada have filed Writ Petitions bearing nos: 32975, 33162 & 35090 of 2022 before the Hon'ble High Court of A.P., on behalf of Private Medical Colleges and Dental Colleges in the State of AP, challenging the various aspects of fee fixation by APHER&MC / Government of Andhra Pradesh. The Hon'ble High Court of A.P., in its Orders Dt. 21/07/2023 stated "this court deems it appropriate to enhance the existing fee of the academic year 2022-23 at the rate of 10% for the academic year 2023-24. The Hon'ble High Court also directed the respondent No. 1 to go ahead with the counseling notification in respect of MBBS admissions and further directed the respondents to notify the enhanced fee for the academic year 2023-24 duly enhancing 10% as a tentative fee i.e. Rs. 13,20,000/- till the fixation of final fee as per the procedure under the provisions of Act 20 of 2019 and rules made there under. The enhancement of fee is also made applicable for the academic years 2024-25 and 2025-26.

That, I am herewith paying the tuition fee of Rs. 13,20,000/- (Thirteen Lakhs Twenty Thousand only) per annum fixed for Management quota (B category) as per the above orders of the Hon'ble High Court of A.P. I further undertake that without prejudice to my rights, I agree to pay the tuition fee payable pursuant to the decision of the Hon'ble High Court in above batch of Writ Petitions or by the Hon'ble Supreme Court of India or Order of the Government or any other authority concerned. I do hereby agree to abide by the final outcome of the above batch of Writ Petitions and also agree to pay the arrears of tuition fee and other fee, if any, fixed by the Government of Andhra Pradesh.

That, I further declare that I am fully conversant with the rules and regulations of Apollo Institute of Medical Sciences & Research, Chittoor in the matter of recovery of pending tuition fee and other fee from its students and that the Management and Administration of the Institution may take any such legal action deemed fit to recover the dues from us.
